### Monroe County Museum

We are extremely thrilled to be named one of the top twenty finalists in this year's Partners in Preservation: Vote Your Main Street competition! Our museum's age is showing, and immediate repairs are critical to protect the building, according to noted preservation architect Nick Holmes III of Mobile. The brick veneer on the courthouse's south side has visibly bulged and shifted out of place. Mr. Holmes says the



museum should move quickly to determine the cause and extent of the damage, and arrest it. "It appears to be an isolated area, but you won't know if the structural support wall underneath is involved until you get in there," he said. Moisture also has taken a toll inside the museum, damaging interior plaster walls near several windows. We have every intention of preserving this structure, not simply because of what it means to our community here in Alabama, but because of what it symbolizes to the nation as a whole. There will be tremendous costs associated with the repairs and we need to secure as much as we can in grants. The Partners in Preservation: Vote You Main Street competition is a vital source for much needed funds to save the wall. This will be our main funding for the repair. ### Brief History of the Courthouse

In 1903, Probate Judge Nicholas J. Stallworth hired Andrew Bryan, a prominent southern municipal architect to design a new courthouse for Monroe County. He envisioned it as the future "Hub of Southwest Alabama." Four of the other six courthouses designed by Bryan still stand in Georgia, Mississippi, and Louisiana. A Louisville, Kentucky contractor, M.J. Lewman, was contracted to build the structure for \$ 29,000.00, but foundation blueprints were missing and basement plans were added, causing the cost to rise. Unfortunately, the citizens of Monroe County were not very impressed with what some called "Stallworth's Folly," and he lost his bid for reelection. Not everyone was so negative: according to the Monroe Journal, "The new courthouse is one of the handsomest and most conveniently appointed in the state and one that would do credit to a county far exceeding Monroe in wealth and population…"

The exterior bricks and other building supplies for the Courthouse were shipped in by rail. Rail service had been established to Monroe County on the Louisville and Nashville Railroad inn 1900. Roads in this area were still dirt wagon tracks. The dome of the Courthouse is made of sheet metal and has been painted both silver and white at different times. The dome clock strikes on the hour now as it did from the beginning. Truman Capote mentions it in "A Christmas Memory": "the courthouse bell sounded so cold and clear." Nelle Harper Lee was born in Monroeville in 1926 and grew up with the old courthouse as the center of all activity on the square. She was a great reader as a child much like her neighbor Truman Capote. One imagines she would have been inspired by the the elegant courtroom of the 1903 courthouse. It is said that she insisted the movie director come here to see it before constructing the set for the movie *To Kill A Mockingbird*.

# **Partners in Preservation**

### **Important Points**

- Partners in Preservation is a community-based partnership, created in 2006 by The National Trust for Historic Preservation and American Express, to engage the public in preserving historic places.
- Partners in Preservation: Main Streets is back for its third year in a row with all of this year's
  sites having a special emphasis on historic places that celebrate the contributions of women in
  Main Street communities across America in honor of the upcoming 100th anniversary of the
  passage of the 19th Amendment.
- This year's 20 sites from across the country will compete for a share of \$2M in grants from American Express, where the top Main Streets will receive funds to preserve their historic site.
- Beginning Sept. 24 through Oct. 29, anyone can vote for their favorite Partners in Preservation: Main Street at VoteYourMainStreet.org, hosted by media partner National Geographic. Up to five votes may be cast each day per person, leading up to announcement day on Oct. 30.
- Each local partner is receiving an initial grant of \$10,000 to increase public awareness of the importance of these historic places and build grassroots support for their Main Street district. Over the past 13 years, the program has provided more than \$25 million in support of more than 250 historic sites across the United States, and has engaged more than a million people.
- The project connects people across the country through a common rallying point: saving local history and recognition for important places in their communities.
- Preservation of our Main Streets is important not only to understand our nation's past, but also to create local economic opportunities and provide a space where communities can come together.
- Partners in Preservation has a proven track record of creating positive change in local communities
